

Green Phase-

- ✓ Scheduling important, Screening protocol, hand sanitize often, avoid mask touch and First-time visitors declare vaccine status for staff monitoring and on-going Identification.
- ✓ Open and most accessible for visitation and outings are allowed for residents.
- ✓ Masks must be worn by all visitors and Highly encouraged for our residents while in common areas or hallways and social distance from others
- ✓ Vaccinated visitors may visit in designated areas and resident rooms without mask and if resident vaccinated.
- ✓ Unvaccinated visitors must always keep their masks on during the visit if it occurs inside the COMMUNITY. This includes inside resident rooms. If children are unable, they must visit outside.
- ✓ Outside visitation areas are mask-less, but please adhere to proper social distancing if either party is unvaccinated.

Yellow-Phase 2

- ✓ Schedule visit with community, Screening protocol, hand sanitize often, avoid mask touch and First-time visitors declare vaccine status for staff monitoring and ongoing Identification
- ✓ Open and accessible to families for visitation and for residents to have outings with their loved ones if they are necessary. We discourage social outings due to increased positivity rates in the county.
- ✓ Masks must be worn by all visitors and is highly recommended for residents while in common areas or hallways and social distance from others
- ✓ Vaccinated visitors may visit in designated areas and resident rooms without mask if the resident is vaccinated
- ✓ Unvaccinated visitors must always keep their masks on during the visit if it occurs inside the COMMUNITY.
- ✓ Outside visitation allowed and if either party is unvaccinated then mask must be worn at all time and both parties should socially distance.

Red-Phase 2: No Outbreak

- ✓ Scheduling visit with community is very important. Screening protocol, hand sanitize often, avoid mask touch and First-time visitors declare vaccine status for staff monitoring and ongoing Identification
- ✓ Visits in designated areas but will not allow in room visitation unless it is under the "Compassionate Care" designation which needs to be approved by the Executive Director.
- ✓ All visitors regardless of vaccination status will be required to wear masks throughout any type of visit. Residents are highly encouraged to wear mask.
- ✓ Outside visitation will still be allowed with mask and social distance but no eating or drinking by the residents or visitors will be allowed during this phase. Food and drink may be given to staff to give to the resident to enjoy after the visit.
- ✓ We are also asking that social distancing be maintained during the
 visit if either the resident or visitor are unvaccinated.
- ✓ Medically necessary visits okay with protocols but social outings discouraged, must advise ED and/or Nurse and follow protocols.
- ✓ Dining and activities are still open

Red-Phase 1: Uncontained Outbreak

Uncontained Outbreak - New positive test result for resident in the building. Testing all residents and staff frequently until contained

- ✓ Community goes into FULL Lock Down Mode
- ✓ Scheduling visit with community is very important. Screening protocol, hand sanitize often, avoid mask touch and First-time visitors declare vaccine status for staff monitoring and ongoing Identification
- ✓ No indoor visits except "Compassion Care" visits scheduled and
 approved by ED and advised of risks
- ✓ Window visits are recommended
- ✓ Outdoor Visits allowed schedule and- both parties adhere to masking and social distancing
- ✓ No Community Dining- In room only, Activities or Outings
- ✓ We recommend all non- urgent doctor visits be postponed, try tele-health but if go out observe protocols, advise medical personnel and transport of the outbreak
- ✓ Residents shelter in place with doors closed
- ✓ Recommend residents as able wear masks when interacting with anyone.

Red-Phase 1: Contained Outbreak

- ✓ Testing has revealed that the outbreak is in one area of the community.
- ✓ The area identified is on FULL Lock Down except to advised and scheduled Compassionate Care visitors.
- ✓ In contained area in room dining only, no group activities
- ✓ Non contained area will allow dining but social distanced
- ✓ Non contained areas- Small group activities allowed with social distanced with masks
- √ No outings
- ✓ Window visitation- scheduled and outside resident room.
- ✓ Preferred outdoor scheduled visitation- social distanced with screening, mask, and hand sanitizing.
- ✓ Community to consult with local public health department on indoor visitation based on situational facts, timing, and scheduling
- ✓ Recommend all non- urgent doctor visits be postponed for those in contained area, try telehealth but if go out observe protocols, advise medical personnel and transport of the outbreak
- ✓ Highly recommend residents wear masks when interacting with anyone.
